2026-2028 Arizona Resident Membership Agreement

2026-2028 Arizona Resident Membership is valid May 1, 2026 through April 30, 2028. The initiation fee for the 2026-2028 Arizona Resident Membership is \$295 including tax.

Resident Membership will be sold to Arizona Residents only. A current/valid Arizona Driver License or Arizona State ID must be presented at time of membership purchase and at time of play (if requested).

Arizona Resident Membership Agreement includes the following green fee rates which are inclusive of any mandated tax:

1. **\$23.00 - Low Season***
 2. **\$42.00 – High Season***
 3. **Winter Twilight Fee - \$23.00 anytime after 2:30 during High Season**
- *High Season is November 1, 2026 thru April 30, 2027 & November 1, 2027 thru April 30, 2028**
***Low Season is May 1, 2026 thru October 31, 2026 & May 1, 2027 thru October 31, 2027**

Applicant understands the Arizona Resident Pass is NOT a 24 month pass. **Initial** _____

Arizona Resident Members must check-in & pay with the golf shop staff before playing golf. To ensure a position on the tee box for you and your guests, tee times are required. For the benefit of all players, our golfers will be committed to playing the course in the designated order or as prescribed by the golf shop staff. **Initial** _____

Proper dress at PPGC is required. No tank tops, cut-off shorts, swimwear or any clothing that management deems inappropriate or offensive will be allowed. No pets or animals of any kind are allowed. **Initial** _____

All golfers will stay out of areas marked “ground under repair” or otherwise protected for the purpose of improved playability. **Initial** _____

Our Arizona Resident Membership is a reduced fee program for 2 season (5/1/2026 through 4/30/2028) for Arizona residents only & applies to “open play”. Tee times can be made up to **7 days** in advance. Open play is defined as anytime there is NOT an organized golf event using tee times at PPGC. Arizona Resident Member fees **DO NOT APPLY** to outside tournament play or any other organized golf event. **Initial** _____

The Arizona Resident Membership is exclusive to the golfer named on this agreement. **Initial** _____

Arizona Resident Members will adhere to course closures, cart path closures, hole maintenance closures and any other directives given by the golf shop staff related to course access on any given day. **Initial** _____

Arizona Resident Members agree that all food & beverage is to be purchased through PPGC. No outside food & beverage will be allowed on the property. **Initial** _____

Arizona Resident Membership green fees include 9 or 18 holes of golf with golf cart. No price concession is given to those golfers that decide to walk or use their personal golf cart. **Initial** _____

The Arizona Resident Membership is not transferable or applicable to anyone other than the membership holder. **Initial** _____

By signing below, and paying the 2026-2028 Arizona Resident Membership initiation fee, you agree to all green fee rates, to abide by PPGC rules & regulations, and agree to accept liability for cart damage/repair cost associated with your use of PPGC golf carts.
